

## Türkiye- UK Business Roundtable Meeting 14 March 2024, London

**Private Sector Representatives,** 

I greet you all on behalf of Foreign Economic Relations Board-DEİK and happy to be here after our 7th term JETCO and Türkiye-UK Roundtable Meetings we held in İstanbul in January.

We have a long history and deep-rooted trade and investment relations that goes back to 1838 when we signed our first trade agreement with UK. Since then, our trade volume approached to \$ 20 billion and UK became our fifth largest trade partner in Europe. Moreover, we also have mutual investments as an another important area.

UK ranked as the 9<sup>th</sup> country with 8 billion \$ FDI in Türkiye, focused in food, energy, infrastructure and tourism. Turkish companies have 4 billion \$ FDI in the UK.

Trade volume and investment level so far is good but we shouldn't satisfy with that. Here to increase these figures main responsibility belongs to business people where our ministers are here to help us.

The significance of our meeting today is enhanced by its timing. This step is a concrete reflection of our mutual dedication to strengthening our strategic alliance. The vision in upgrading should be to leverage the complementary strengths of both countries with a forward-looking concept.

I would like to finish my speech with a British saying, "Success breeds success." I believe, as Turkish and British business representatives, we will work more to enhance our economic relations and it will breed more achievements.
