Our bilateral trade is about \$1.8 billion, and I believe we have potential to increase, of course not only to increase but also in a balanced way. Beyond the trade, it is crucial that, economic and cultural relations expand into different areas, diversifying from investments to partnerships.

Let me underline few points, which I believe will help to develop our cooperation;

- First of all, we always emphasize that there is an urgent need for modernization of Customs Union, focusing on; agriculture, services and public procurement.
- As green and digital transformation go hand in hand, digital transformation is another specific area where we can cooperate more through DEİK's Digital Technologies Business Council.
- I'd like to highlight challenges, faced by Turkish steel companies due to the quota restrictions imposed by EU.
  Despite Türkiye's strong industrial capacity and commitment to high-quality production standards, these quotas continue to constrain sector's potential for growth and competitiveness in EU market.

- Both countries' industries seem to complement each other. In addition to other points, construction, energy and defense are leading areas of cooperation, as well as; medical services, information and communication, digital and environmental technologies.
- Now, let me move on Türkiye's side.
