We certainly hope there will be a compromise for Free Trade Agreement between our countries that will further improve our cooperation.

Despite the challenges of Covid-19, we are now learning that there is a paradigm shift. I will not talk about the health aspect of the issue. However, we had to comply with the social distance rule including working from home. The coronavirus has turned our lives upside down; and for a sector as big as education, decision-making become a difficult exercise.

Economic Scale was an important parameter for competition, but we noticed that it also creates the problem of being bounded to one or limited supplier. So supply chain diversification became more important than ever and it took more important position in our life.

Also, the epidemic process directly affected international education. There is a difficult process in this area and education in the world is probably evolving in a different direction. It is important to keep up with this change and to work on future education models.

Such as the need for our universities to diversify their resources while concentrating more on operational efficiencies and to improve academic results, to effectively integrate technology, to design university-industry cooperation from scratch without considering stereotypes, and to ensure governance and stakeholder engagement.

Like the fact that higher education must become even more important with increasing automation and digitalization.

Universities that quickly adapt to global trends, strive harder to increase their international activities and change themselves.

As DEİK, we continue our work with all our partners intending to establish permanent relations between our countries and increase our economic relations to higher levels.
