100% payment must be made upon receipt of the issued invoice after signing the agreement.

General Terms and Conditions:

1.1. Turkmen Expo will provide international exhibitors using exhibition space with support in obtaining a Turkmen visa. The visa fee and related service charges are not covered by this agreement. **In case of rejected visa we will refund the package cost except of visa support fee.**

1.2. The Exhibitor will only be confirmed and allowed to set up their display in the exhibition space after full payment and approval of the booth design in alignment with the exhibition's official concept.

1.3. The Exhibitor's rights cannot be transferred to any other party or individual, and the information provided by the Exhibitor is also non-transferable.

1.4. This document is strictly confidential and intended exclusively for the recipient's use. It cannot be distributed without prior written consent from Turkmen Expo.

1.5. If the exhibitor fails to attend the exhibition for the reasons outlined below, the Exhibitor shall compensate Turkmen Expo as follows:

100% (one hundred percent) of the total cost of the rented exhibition space, as well as payment for (standard) administrative and banking expenses incurred by Turkmen Expo, if the participant fails to attend the International Exhibition due to their own fault. 100% (one hundred percent) of the total cost of the rented exhibition space and payment for (furnished premises) administrative and banking expenses incurred by Turkmen Expo, if the participant damages the rented display area through their own fault.

1.6. If the Exhibitor is unable to attend the exhibition for any reason, they may provide a replacement, provided that Turkmen Expo receives prior notification 20 (twenty) business days in advance, including the name of the proposed replacement (for foreign nationals requiring a visa).

1.7. Turkmen Expo, its agents, or employees are not responsible for:

a) Any loss, theft, or damage caused by fire or injury of any kind to any person or personal belongings.

b) Any loss, damage, or delay caused by military actions, civil unrest, strikes, lockouts, intervention or regulation, military activities, or any other circumstances that make it impossible or unwise to hold the exhibition at the scheduled time and place.

c) Any loss resulting from the cancellation, abandonment, postponement, or shortening of the exhibition due to circumstances beyond their control. Exhibitors are advised to insure their participation costs adequately in the event of cancellation, refusal, delay, or reduction.

d) Any disputes or misinterpretations arising with the host country, its agents, or other bodies concerning any aspect of the exhibition that may affect the Exhibitor.

1.8. In the event of force majeure, both parties:

a) Are released from liability if the proper execution of the agreement becomes impossible.

b) Must coordinate an appropriate alternative implementation of the agreement.

1.9. These Terms and Conditions, as well as the rights and obligations of both parties, shall be governed by and interpreted in accordance with the laws of Turkmenistan. Any disputes arising from this Agreement shall be subject to the jurisdiction of the Court of Turkmenistan.
